PRE – APPROVAL CHECKLIST

- 1. Formal Application on letterhead
- 2. Duly completed Online Loan Application Form
- 3. Photocopy of Business Registration Certificate & Forms
- 4. Business Plan which should include a brief Profile of the Business Enterprise and business activity
- 5. Background, Qualifications and Experience of the key Management Staff
- 6. Quotation/ Proforma Invoice for the supply of items of Machinery and Equipment
- 7. Sources and quotations for Raw Materials expressed in quantity and amount
- 8. Digital passport photographs (Visa specifications)
- 9. Biometrics Verification Number (BVN) of the Promoter(s) (i.e. business owner[s])
- 10. Means of identification of the Promoter(s) (i.e. photocopy of International Passport or Driver's License or National Identity Card or Permanent Voter's Card)
- 11. Bank Statement of the Business Enterprise for a period of one (1) year (for existing business) or Statement of Affairs (for new businesses)
- 12. Declaration of Outstanding Liabilities to other Banks and Individuals (on letterhead)
- 13. Security:
 - (a) Digital copy of Higher Institution Degree Certificate (Bsc/HND or equivalent)
 - (b) Digital copy of NYSC Discharge Certificate
 - (c) Certificate issued by Polytechnics or Universities evidencing entrepreneurship training
 - (d) Duly signed Global Standing Instruction (GSI)

(e) Third party guarantee (a senior federal/state civil or public servant), clergy, recognized traditional ruler, registered professionals (lawyers, accountants, doctors, bankers, architects etc.), confirmed staff of established companies.

POST – APPROVAL CHECKLIST

- 1. Submission of Letter of Offer duly endorsed by the Proprietor(s)
- 2. Letter of Acceptance of Offer signed by the Proprietor(s)
- 3. Return of executed Loan Agreements duly endorsed by the Proprietor(s)
- 4. Letter showing specimen signature of the Proprietor(s)
- 5. Individual External Guarantors (if applicable):
 - (a) Means of identification (i.e. photocopy of International Passport or Driver's License or National Identity Card or Permanent Voter's Card)
 - (b) Four (4) Passport photographs
 - (c) Notarized Statement of Net-Worth (Form will be issued by BOI)
 - (d) BVN
 - (e) Curriculum Vitae of the Guarantor(s)
- 6. Submission of the original proforma invoice(s) of the items to be financed
- 7. Submission of the original GSI and Third Party Guarantee Forms
