Key responsibilities include overseeing hub operations, stakeholder engagement, monitoring and evaluation, performance management, reporting, and compliance with programme standards. The Centres of Excellence aim to strengthen Nigeria's digital and creative ecosystem by providing young people aged 15–35 with access to quality skills development, mentorship, innovation support, and pathways to employment and entrepreneurship.
