Summary of Scope of Contract Awarded: The consultancy is a regional Business Process Outsourcing (BPO) implementation contract designed to strengthen Nigeria's digital and creative economy by delivering market-ready training and employment linkages across the country's six geopolitical regions. Under the contract, the consultant will identify, recruit, train, and support beneficiaries in BPO-related skills such as call centre operations, IT support services, outsourcing operations, and other digital-enabled services, using a hybrid delivery model that combines virtual and physical training over the implementation period. The scope also includes developing and deploying training curricula aligned with global industry standards, engaging employers and industry partners, facilitating internships and job placements, and providing post-training support to promote both employment and self-employment opportunities. In line with the programme's objectives, performance will be measured not only by the number of beneficiaries trained but also by the effectiveness of job placement, employer linkages, and the creation of sustainable work opportunities for participants.
